We jointly and severally agree that neither/none of us shall sell or assign his or her share in the Horse/Horses or any part thereof without the consent of the other/others and that in the event of such consent not being received or in the event of any difference or dispute arising between us/anyone or more of us and the other or others either with regard to the sale of a share of interest in the horse or otherwise, and such dispute being referred by either/any of us the Stewards of the Club the Stewards of the Club shall be entitled to decide such difference or dispute in such manner as they deem proper and/or to put up the entire horse for sale by public auction at any recognised race meeting and pay the net sale proceeds, after deducting their expenses if any, to us, the undersigned, in proportion to our respective shares in the Horse/Horses

We jointly and severally further hereby expressly agree that in case of any dispute and / or default arising between us / anyone or more of us and the other or others either with regard to payment of any amount to any party i.e., the Club or the Trainer concerned or any other Turf Authority under whose rules our horse may race, any partner/s will be authorised to write to the RWITC, Ltd. and arrange for a public auction sale of the above mentioned horse under the rules of the Club so as to dissolve this partnership and we also hereby expressly agree that if there is any shortfall at the said auction, we / anyone or more of us and the other or others undertake to make good such shortfall in the purchase price of the said horse to the extent of the liability to the Club or Trainer by the defaulting partner/s.

We jointly and severally also further expressly agree to abide by the conditions, restrictive or otherwise, attached to the scheme of financial assistance granted by the Club to us/ anyone or more of us and the other or others and any matter arising out of such public auction sale or dissolution of partnership shall be decided by the Stewards of the Club/ Committee at their sole and absolute discretion and such decision/s shall not be capable of being questioned in any Court of Law and we also agree that their decision/s shall be final and binding on everyone of us.

We, jointly and severally, hereby consent and undertake to be bound by the Articles of Association, Rules of Racing, Notification, bye-laws, other rules and regulation etc. of the Club which are in force from time to time, including without limitation, the provisions relating to the exclusive jurisdiction of Mumbai Courts only.
