- 1. I am a person resident of India, within the meaning of the Foreign Exchange Management Act 1999 ("the Act").*

- 1. I note that if this form is incomplete, it will be returned to me and may cause an inordinate delay. As such, I am advised to see that all the required information is clearly stated. If at a later date, the Stewards find that any of the above particulars furnished by me are incorrect, they will be at liberty to take any action against me that they may deem necessary under the Rules of Racing and to cancel the ownership of the horse/s forthwith.*

I confirm that I am bound by the Rules of Racing, notifications, by-laws and all rules of RWITC Ltd., prescribed from time to time, and in particular Rule 41(n) relating to the payment of the basic training fees to trainers and dues of the Club and confirm to be bound by the decisions of the Stewards of the aforesaid Club.*
- 3. My husband/Wife (as the case may be) is approved as owner, I agree that in the event of the Stewards taking action against him/her, it would be open for the Stewards to inquire into my ownership and, at their discretion, to either revoke my approval or prohibit the transfer of horses from such person to me.*
- 4. I am fully aware as to the cost of maintaining and racing a horse and the abovementioned particulars as stated by me are correct in every respect and no other persons have any interest, financial or otherwise, in my share in the abovementioned horse/s.*
