(the "Club") and by the decisions of the Stewards of the Royal Western India Turf Club Ltd including cancellation / withdrawal of Ownership. No other person/s has/have any interest, financial or otherwise in the _____ horse/s, except as intimated in the covering letter.

We also agree to be bound by all decisions of any/ al bodies constituted under the Article of Association/ Rules of Racing of the Club including the Board of Appeal, Committee of the Club etc, as the case may be. We send you herewith true certified copies of the Partnership Deed of the Firm, latest Statement of Account and Solvency Proof, latest Annual Report and list of Partners of the Firm and their addresses.

We undertake to intimate to the Club immediately any change in the constitution of Partners of the Firm and its Address / address of the Partners of the Firm or such other information as required and to submit to the Club on the first of April every year, all such information and documents listed in Appendix " I " of the Rules of Racing of the Club.

We agree that the horses owned by the Firm shall not be entitled to run in races run under the control of any Turf Authority of India, if the name of the Authorised Agent nominated by the Firm is notified under the Unpaid Forfeit List or for non-payment of Feeding & Upkeep Charges.

The Firm shall nominate an Authorised Agent whose name, address and signature is appended herewith.

The permission, if granted, will stand automatically cancelled if the Firm ceases to be the owner of any horse/s at the time of renewal each year i.e. 30th April.

We hereby consent and undertake to be bound by the applicable provisions of the Articles of Association, Rules of Racing, Notifications, bye-laws, other rules and regulation etc. of the Club which are in force from time to time, including without limitation, the provisions relating to the exclusive jurisdiction of Mumbai Courts only.

We hereby also consent to ensure compliance with the provisions of the Indian Partnership Act, 1932 or any amendment or re-enactment thereof, including without limitation, the provisions relating to the minimum and maximum number of Partners under the aforesaid Act.

We hereby undertake that this Declaration and Undertaking made by the Partners of the Firm shall at all times be binding on the Firm as also its Partners, jointly and severally.

We enclose herewith a fee of Rs.100/- payable for registration of the applicant Firm as an Owner and agree and undertake to pay the renewal fees every year as prescribed from time to time.

We acknowledge that:

- a) The decision of the Stewards of the Club whether to grant such approval is final and binding upon us, the applicant/s;
- b) The Stewards of the Club are not bound to give any reasons for their decision as the matter falls within their discretionary powers;
- c) The authority to grant approval of ownership under the rules vests in the Stewards of the Club.
