- (b) In the case of sons/daughters of deceased Club /Stand/Life/LadyStandMembers, priority in election will be given likewise as aforesaid if they are proposed as candidates within one year from the death of such Club/Stand/Life/Lady Stand Members and in the event of such son/daughter being a minor at the time of death of such members as aforesaid, then within one year of such son/daughter attaining the age of 18 years for Stand Membership, Life Membership or Lady Stand Membership and within one year of such candidate attaining the age of 23 years for Club Membership.
