4. THE PROPOSER OR SECONDER MUST BE PRESENT TO INTRODUCE HIS/HER CANDIDATE TO THE COMMITTEE AT THE TIME THE CANDIDATE IS CALLED FOR ELECTION AND NO SUBSTITUTE CLUB MEMBER SHALL BE ALLOWED TO INTRODUCE THE CANDIDATE.

SPECIAL NOTICE

As per Article 15 of the Articles of Association of the Club as amended on 15th September 1994

- (a) Sons/daughters of existing Club / Stand / Life Members (who have been members of the Club for not less than 10 years) shall be given priority in election to other candidates as Club / Life / Stand Members as the case may be, after the applicable list existing as on 15th September 1994. i.e. the date of the Annual General Meeting has been cleared.
- (b) In the case of sons / daughters of deceased Club / Stand / Life Members, priority in election will be given like wise as aforesaid if they are proposed as candidates within one year from the death of such Club / Stand / Life Members and in the event of such son/daughter being a minor at the time of death of such members as aforesaid, then within one year of such son/daughter attaining the age of 18 years for Stand Membership or Life Membership and within one year of such candidate attaining the age of 23 years for Club Membership.

In case of candidate falling under Clause (b) above, he/she is required to submit his/her **birth certificate** (original / copy) or any other document of proof to show that he/she is a son/daughter of a deceased member and also the death certificate (original/ copy) along with this form.

A married daughter will also be required to submit a copy of her marriage certificate in addition to the above.

The birth certificate or any other document submitted with this form should contain the name of the candidate as also the name of his / her father / mother who is / was a member of the Club, separately.

ENTRANCE FEE

(a) The entrance fee payable by sons of Club / Stand / Life Members of the Club is Rs. 2 lakhs, plus applicable taxes, provided they apply prior to completing 30 years of age.

(b) The entrance fee payable by unmarried daughters of Club / Stand / Life Members of the Club is also Rs. 2 lakhs, plus applicable taxes. In the case of married daughters they are required to apply for Life Membership of the Club within 2 years from the date of their marriage or they apply prior to their completing the age of 30 years, whichever is later.

(c) The entrance fee payable by sons or married daughters of Club / Stand / Life members of the Club is Rs. 5 lakhs, plus applicable taxes, if such sons or married daughters have not applied for Membership under sub-clauses (a) or (b) above.

(d) The entrance fee for all other persons (except those covered under (a), (b) and (c) above) shall be as fixed by the Committee of the Club from time to time.

NOTE TO THE ABOVE :

THE REDUCED ENTRANCE FEES, AS STATED IN (a) & (b) ABOVE SHALL BE APPLICABLE ONLY IF EITHER OF THEIR PARENTS ARE OR HAVE BEEN CLUB OR STAND OR LIFE MEMBERS OF THE CLUB FOR AT LEAST 5 (FIVE) PRECEDING YEARS.

Attention of Applicants is initiated to the provision of Article 24 (A) of the Articles of Association of the Club which is quoted below :

24(A) "All Club, Stand and Life Members, elected as such Members after the date of adoption of this Resolution i.e. after 21st September, 2023, (excluding existing Club / Stand / Life Members as also existing Life / Stand Members of the Club who may become Club Members after the date of adoption of this Resolution), shall pay to the Club, in advance, on the First Day of April, of each Calendar Year, annual charges ("Annual Charges") towards upkeep, maintenance etc., of Club's assets, property, equipment and infrastructure of such amount as may be fixed by the Committee of the Club from time to time. If any of the aforesaid Club, Life or Stand Members shall fail to pay the Annual Charges within the time stipulated above, notice shall be sent by the Club to such Member(s) by registered letter or email, to his / her last registered address / email id calling his / her attention there to and if such Member does not pay the amount within 30 (thirty) days of the posting of such notice or the date on which email was sent, then, notwithstanding anything contained to the contrary in the Articles, the membership of such Member shall stand automatically suspended pending payment of his / her Annual Charges to the Club. Upon payment of the Annual Charges, the membership of such Member shall be restored by the Club. In addition to the aforesaid, the Committee of the Club shall be entitled to take such further action against such Member as provided in the Articles, including without limitation, removal of his / her name from the Register of Members."
